1.Introductions / Welcome to The Red Bull, Barton Rd, Cambridge 20.00 start

Minutes of AGM 22.9.2017 were available. The actions were gone through and approved.

2. League and match reports (J,C.)

Thank you once again to John Chambers from Spalding for the work he has done in maintaining the league website. http://www.cambsvolleyball.org.uk/

Men: match delays were caught up (just 1 or 2 missing matches). The e-score sheets were sent in so none missing. Some clubs play multiple leagues and have little time for match rearrangement. There were also some issues about getting referees for rearranged matches - all parties need to be informed of changes. (The non-cancelling team can claim a walkover). Spalding found the matches tougher this season.

Women: ARU struggled term time to find players. Bedford withdrew. Match reports were ok. Some matches were rearranged and replayed.

Walton Shield - Cambridge University Sports Hall is a great venue for this. Will aim to secure a booking earlier for next season (after Uni exams have finished).

Reminder - first 20 mins is warmup - if teams are late, the first set could be defaulted. Suggestion to invite teams 15 mins before the court time begins since it is often difficult to complete a long match in a 2-hour slot.

3. Chairman's report (H.S.)

Leagues and tournament have run well and HS apologised for taking a back seat this year. Thanks to Dino for setting-up/running the ladies' league. There seem to have been some issues with the referees - clubs could send refs that are more experienced to 'tougher matches'. Only the captain-on-court should approach the referee. The captain needs to control more vocal/ dissenting team players. Timings need to be prompt for warmup, change of ends and time outs.

Players can make up numbers for any team if asked, though active recruiting is to be avoided. The ethos is to promote volleyball (and cancel fewer matches).

There was some debate about whether the teams should limit the number of coopted national league players. Essentially this is difficult to monitor and any potential fines could have a negative effect on numbers of teams entering the league.

A motion was passed requiring all 2018-19 teams to identify registered NVL players on the scoresheet with an asterisk *. This is for information purposes only.

4. Financial report and accounts (D.B.)

D.B. to stand down as Spalding are not in the league for the next season. Copies of the accounts were explained and circulated to those present. The accounts were voted for and accepted.

Seven men's teams have expressed initial interest for the league 2018-19: Cambourne Chargers, Cambridge VC, Peterborough Harriers, Newmarket, Rhinos, St. Philips and Werrington. This will require 12 matches (home and away). Matches should be played October to March, April is a buffer month. The Walton Shield will be played in May/June 2018.

Four women's teams have expressed initial interest for the 2018-19 league so far: Rhinos, St. Philips, Cambridge VC, and Peterborough Harriers VC. (6 matches - home and away). ARU may join the league later, depending on how recruitment goes once the term has started.

5. Deposit and Fines

Fines have been taken from the good will deposit. This will need topping up for the new season. UL to notify teams with application forms and fees due. (See treasurers report page 2)

6. Women's League (D.O.)

It was great that the league took off. Thanks to J.C. for doing all the fixtures. The Walton Shield was hard as this was over the men's height net. Hopefully the new league will start in November when training has kicked in. DO felt there was no need to have an officer to cover the league as it was run alongside the same rules as the men.

There was more debate about whether players could be borrowed and the number of NVL players on court at any time. JC said it was difficult to have a middle line, players would need to be registered with the club and checked or anyone can play for any club. If this was to become a rule, there would need to be a penalty (which needs monitoring) - volleyball play should be encouraged.

7. Committee elections

All members were elected unopposed. Vice chair role added to keep a committee of 5.

Treasurers Report

The season 2017/18 showed a profit of £292.40 which includes Goodwill deposit transactions for new League members.

I have been unable to contact Norwich VC regarding the £40 outstanding goodwill deposit still held by CVA, they had previously offered to forfeit their deposit in compensation for withdrawing from the league mid-season 2016/17. I suggest accepting this position for CVA to keep the outstanding £40.

Bedford women's team have indicated that they will not participate in league season 2018/19, they have been reimbursed goodwill deposit of £100.

Spalding VC have indicated that they will not participate in league season 2018/19, they have been reimbursed the balance goodwill deposit of £50.

Expenses increased this year due to increased number of medals, slightly higher hall fees for Walton Shield and reimbursement of referee courses. This was balanced by the increased income from league entry fee and fines. AGM room hire fees not included. Next year's fines of £140 and Walton shield entry fees of £120 will show in 2018/19 accounts and are shown in the Goodwill section in 2017/18.

The bank balance includes £ 1040 in Goodwill deposits.

Almost all clubs paid their league entry fees promptly. It would be very helpful the treasurer did not have to chase clubs for payment for the for 2018/19 season.
